It describes all the activities included in a Halal certification process, and provide an overview of the procedure for handling halal certification for companies exporting to GSO Member States.

4. Terms and definitions

- 4.1 **Consultancy**: participation in:
 - The designing, manufacturing, installing, maintaining or distributing of a certified product or a product to be certified, or
 - The designing, implementing, operating or maintaining of a certified process or a process to be certified, or
 - The designing, implementing, providing or maintaining of a certified service or a service to be certified.
- 4.2 **Complaint**: Expression of dissatisfaction, other than appeal, by any person or organization to a conformity assessment body or accreditation body, relating to the activities of that body, where a response is expected
- 4.3 **Appeal**: request by the provider of the object of conformity assessment to the conformity assessment body or accreditation body for reconsideration by that body of a decision it has made relating to that object
- 4.4 **Surveillance**: systematic iteration of conformity assessment activities as a basis for maintaining the validity of the statement of conformity
- 4.5 **Suspension**: temporary invalidation of the statement of conformity for all or part of the specified scope of attestation
- 4.6 **Withdrawal**: cancellation of the statement of conformity
- 4.7 **Conformity assessment**: demonstration that specified requirements relating to a product, process, system, person or body are fulfilled
- 4.8 **Conformity assessment body**: body that performs conformity assessment services
- 4.9 **Accreditation body**: authoritative body that performs accreditation
- 4.10 Third-party conformity assessment activity: conformity assessment activity that is performed by a person or body that is independent of the person or organization that provides the object, and of user interests in that object
- 4.11 **Sampling**: provision of a sample of the object of conformity assessment, according to a procedure
- 4.12 **Testing**: determination of one or more characteristics of an object of conformity assessment, according to a procedure
- 4.13 **Inspection**: examination of a product design, product, process or installation and determination of its conformity with specific requirements or, on the basis of professional judgement, with general requirements

- 4.14 Audit: systematic, independent, documented process for obtaining records, statements of fact or other relevant information and assessing them objectively to determine the extent to which specified requirements are fulfilled
- 4.15 **Review**: verification of the suitability, adequacy and effective- ness of selection and determination activities, and the results of these activities, with regard to fulfilment of specified requirements by an object of conformity assessment
- 4.16 **Certification**: third-party attestation related to products, processes, systems or persons
- 4.17 **Accreditation**: third-party attestation related to a conformity assessment body conveying formal demonstration of its competence to carry out specific conformity assessment tasks
- 4.18 **Attestation**: issue of a statement, based on a decision following review, that fulfilment of specified requirements has been demonstrated
- 4.19 Halal Competent Authority: Authorities in GSO Member States in charge of enforcing the halal regulations, namely Emirates Authority for Standardization and Metrology (ESMA) in UAE, Saudi Food and Drug Administration (SFDA) in Kingdom of Saudi Arabia, etc.
- 4.20 **GSO Member States**: Member States of the Standardization Organization for the Cooperation Council for the Arab States of the Gulf (United Arab Emirates, Kingdom of Bahrain, Kingdom of Saudi Arabia, Sultanate of Oman, State of Qatar, State of Kuwait and Republic of Yemen).
- 4.21 Hazard Analysis Critical Control Points (HACCP): internationally recognized method of identifying and managing food safety related risk, namely Physical, Chemical and Biological Hazards.
 - 4.22 **Competence**: ability to apply knowledge and skills to achieve intended results
 - 4.23 **Non-conformity**: non-fulfilment of a requirement
 - 4.24 **Applicant**: A person or a legal entity who applies for certification of Halal for a product/service.
 - 4.25 **Evaluation**: combination of the selection and determination functions of conformity assessment activities

- 7.2.2 When a halal issue is not handled by any Halal GSO Standards, fatwas on the same matter issued by International Islamic Figh Academy shall be fulfilled.
- 7.2.3 When there is a difference in meaning between the requirements in English and Arabic Versions of GSO Standards, the Arabic Version shall prevail.

7.3 Sampling processes in the scheme

- 7.3.1 When sampling is required, it shall be performed according to Clause 9.6.2 of GSO 2055-2.
- 7.3.2 The samples need to be representative of products to halal certified and it shall be in accordance with a defined sampling scheme utilising statistically proven techniques with stated confidence levels as stated in Clause 9.2.6.2 of GSO 2055-2. Samples taken by the audit team shall be sent for analysis to the laboratory accredited under ISO/IEC 17025.
- 7.4 Sequence of a certification cycle and involved activities

The Certification Cycle is for three years and include a two-stage initial audit, surveillance audit in the first and the second years, and a recertification audit in the third year prior to expiration of certification.

- 7.4.1 Application for certification and certification agreement
 - 7.4.1.1 The applicant may submit an inquiry about halal certification according to Halal GSO standards to AMO (By email..., By fax...., By mail....). All enquiries will be handled by..., within XX days.
 - 7.4.1.2 The applicant shall submit an application (AMO-08) and provide the necessary information to complete the certification process in accordance with this Halal certification scheme, namely the following:
 - Relevant details of the applicant organization, including its name and the address(es) of its site(s), its processes and operations, human and technical resources, functions, relationships and any relevant legal obligations;
 - Desired scope of halal certification;
 - Detailed information concerning process lines concerned;
 - Detailed information concerning the certifications earned by the product/activity seeking Halal certification (ISO 22000, FSSC, IFS, BRC, etc.);
 - Number of HACCP studies;
 - Number of shifts and number of employees per shift (including temporary employees);
 - Identification of outsourced processes used by the organization that will affect conformity to requirements;

 - Product Labels/ Artworks;
 - Halal Certificates of Ingredients, Raw Materials and Packaging Materials;
 - Site Diagram, Factory Layout, description of Manufacturing Process & Plant Equipment Layout showing all the identified Halal CCP;
 - List of Ingredients, Raw Materials and Processing Aids, including concentrations, scientific denomination and CAS number;
 - Finished Products list and specifications.
- 7.4.1.4 The application review will be handled by a qualified personnel fulfilling the competency requirements sated in Clause 7.2.2 of GSO 2055-2, and will be performed according to AMO's Halal Certification Procedure.

- 7.4.1.5 The application reviewer shall conduct a review of the application and the additional documents to ensure that:
 - 7.4.1.5.1 The information about the client and the product is sufficient for the conduct of the certification process;
 - 7.4.1.5.2 Any known difference in understanding between AMO and the client is resolved, including agreement regarding halal requirements;
 - 7.4.1.5.3 The scope of certification sought is defined;
 - 7.4.1.5.4 The means are available to perform all evaluation activities;
 - 7.4.1.5.5 The requested products/activities to be Halal certified are within the scope of accreditation of AMO;
 - 7.4.1.5.6 AMO has the competence and capability to perform the certification activity;
 - 7.4.1.5.7 The Audit time is calculated according to the Procedure for Audit Time Calculation (Include the reference of this document), which is based on Annex B of GSO 2055-2;
 - 7.4.1.5.8 The appointed Audit Team consists of at least one Technical Auditor and one Halal Islamic Affairs Expert fulfilling the competency requirements stated in Clause 7.2 of GSO 2055-2 and that there is no conflict of interest between the Audit Team and the client;
 - 7.4.1.5.9 The points influencing the certification activity are taken into account, for instance the site(s) of the applicant organization's operations, audit day, season, time required to complete audits language, safety conditions, threats to impartiality, etc.
 - 7.4.1.5.10 The Audit Team is accepted by the Applicant/Client;
 - 7.4.1.5.11 The Applicant/Client accepts the Audit time.
- 7.4.1.6 Following the review of the application, AMO shall decline an application for certification and no Proposal for Certification shall be prepared if:
 - 7.4.1.6.1 AMO doesn't have the competence and capability to perform the certification activity;
 - 7.4.1.6.2 AMO can't proceed to the certification activity within the time line requested by the Applicant;
 - 7.4.1.6.3 The above requirements are not fulfilled;
 - 7.4.1.6.4 The required documents have not been provided by the Applicant/Client.

- 7.4.1.7 If the application accepted by AMO, a Proposal for Certification will be completed by the assigned Application Reviewer and approved by the Certification Manager. The proposal will include the competence needed for the audit team and the decision committee, the required audit time, the fees and person-days, the preliminary scope of certification.
- 7.4.1.8 AMO shall precisely define the scope of certification in terms of Halal product/service categories, e.g. primary production (raw material or intermediate product), food processing, packaging material production, etc., and sectors according to Annex A. AMO shall not exclude part of the processes, sectors, products or services from the scope of certification when those processes, sectors, products or services influence the Halal requirements of the end products.
- 7.4.1.9 AMO will define the preliminary scope of certification in the Proposal for Certification, and in Halal Certification Agreement.
- 7.4.1.10 The Applicant/Client will be required to approve the Proposal for Certification, sign the Halal Certification Agreement and pays the required fees.
- 7.4.1.11 When the Client would like to make any change to the existing Halal certification scope or to add a new line item, the Application Reviewer shall review the Proposal for Certification in order to adjust if needed the calculation of the audit duration. The file manager will advise the Client of any additional costs incurred by the adjustment in the audit duration.

7.4.2 Conformity Assessment Procedures

- 7.4.2.1 General
 - 7.4.2.1.1 The certification process is in accordance with Clause 9 of GSO 2055-2 and detailed in the Halal Certification Procedure. This Scheme will give guidance and explanation of some important steps.
 - 7.4.2.1.2 For Multi-site clients each site is to be halal certified separately.
- 7.4.2.2 Evaluation plan

The *evaluation plan* is based on the *outcome* of the application review. It will include, stage 1 audit, stage 2 audit, sampling and testing activities.

- 7.4.2.3 Acceptance of conformity results generated prior to the application or provided by the client
 - 7.4.2.3.1 AMO may consider test reports and/or Halal certificates supplied by the client according to the Halal Certification Procedure.
 - 7.4.2.3.2 If additional testing and/or inspection is needed it will be handled according to the Halal Certification Procedure.

7.4.3 Evaluation

- 7.4.3.1 General
 - 7.4.3.1.1 AMO will not start conformity assessment before an application review is dully completed and an agreement is signed by the client.
 - 7.4.3.1.2 In general, the conformity assessment consists on the following steps:
 - Stage 1 audit, performed on-site at the facility of the client for products in category (C, D, E, F, L, M and N) as required by Clause 9.2.3.1.3 of GSO 2055-2. The Stage 1 audit will be performed according to the Halal Certification Procedure;
 - If AMO is satisfied with the outcome of stage 1 audit, then the Stage
 2 audit (on-site audit) is performed according to the Halal Certification Procedure;
 - When determining the interval between stage 1 audit and stage 2 audit, AMO will take into consideration the time needed by the client to resolve areas of concern identified during stage 1. Nevertheless, the interval between Stage 1 audit and Stage 2 audit shall not exceed 6 months as required by Clause 9.2.3.1.6 of GSO 2055-2;
 - Sampling, Testing and Inspection will be performed according to the Halal Certification Procedure;
 - When outsourced, Sampling and Testing activities shall be carried out by ISO/IEC 17025 accredited bodies;
 - When outsourced, Inspection activities shall be carried out by ISO/IEC 17020 accredited bodies.

- 7.4.4.1 The Non-conformities will be graded based on the following criteria:
 - A Critical Non-conformity is issued when the halal integrity and food safety is directly impacted during the audit or when legality and/or certification integrity are at stake.
 - A Major Non-conformity shall be issued when the finding affects the capability of the Halal Assurance System to achieve intended results.



7.6.3 Changes by client

The client informs the certification body about any intended modification to 7.6.3.1 the product, raw materials, ingredients, processing aids, packaging, production process or management system which may affect the conformity of the product. AMO determines whether the announced changes require another initial testing and assessment or other further investigations. In such cases, the client is not permitted to release products under the Halal certificate resulting from such changes until AMO has notified the client accordingly.

7.7 Termination, Reduction, Suspension or Withdrawal of halal certification

- 7.7.1 When a Non-conformity with halal certification requirements is substantiated, either as a result of surveillance or otherwise, AMO shall apply the procedure for Termination, Reduction, Suspension or Withdrawal of Halal certification, namely considering and deciding upon the appropriate action, as follows:
 - Continuation of certification under conditions specified by the certification body (e.g. increased surveillance);
 - Reduction in the scope of certification to remove nonconforming product variants;
 - Suspension of the certification pending remedial action by the client;
 - Withdrawal of the certification.
- 7.7.2 When the appropriate action includes evaluation, review and a certification decision, it shall be completed in accordance with Sections 1.4.3 to 1.4.8 of Clause 7 of this scheme.

- 7.7.8 If a decision to reduce the scope of halal certification is made as a condition of reinstatement, AMO shall make all necessary modifications to Halal certificates, public information, authorizations for use of Halal mark, etc., in order to ensure the reduced scope of certification is clearly communicated to the client and clearly specified in certification documentation and public information, namely updating accordingly its website.

7.8 Special audits

AMO may be required to perform special audits, especially to handle scope extension requests, to investigate complaints, or in response to changes, or as follow-up on suspended clients.

7.8.1 Extensions to scope

- 7.8.1.1 The certification body shall, in response to an application for extension to the scope of a halal certification already granted, undertake a special audit. This may be conducted in conjunction with a surveillance audit and in accordance with the Halal Certification Procedure.
- 7.8.1.2 The evaluation, review and decision needed to extend the scope of halal certification shall be completed in accordance with Sections 1.4.3 to 1.4.8 of Clause 7 of this scheme.
- 7.8.1.3 The AMO website is updated accordingly to extend the scope of halal certification of the client.
- 7.8.1.4 Short-notice audits
- 7.8.1.5 AMO may conduct audits of certified clients at short-notice to investigate complaints, or in response to changes, or as follow-up on suspended clients.
- 7.8.1.6 In such cases, AMO shall describe and make known in advance to the certified clients the conditions under which these short notice visits are to be conducted, and shall handle such audits according to the Halal Certification Procedure.

7.9 Confidentiality

AMO is responsible for ensuring that confidentiality of information is maintained by its personnel, including any committee members, personnel of external bodies, or personnel acting on the certification body's behalf concerning all information obtained or created as a result of their contacts with the client, except as required by law or otherwise agreed with the client; this applies also to information obtained at the application stage.

7.10 Product liability

In this scheme, all questions related to product liability are dealt with on the basis of the relevant legal system(s).

7.11 Complaints and appeals

The client has a right to complain to AMO about aspects of the service provided. The client may also appeal to AMO against its decisions on issuing, maintaining, extending, reducing, suspending and withdrawing certification. In all of these cases, AMO will apply the procedure related to Complaints and Appeals which is based on Clause 9.7 of GSO 2055-2 requirements.

7.12 Fees

The applicant shall pay the necessary fees in accordance with the Schedule of Fees issued by AMO.
